### Commissioners to meet Tuesday & Wednesday

Members of the Kaho'olawe Island Reserve Commission (KIRC) will convene two meetings next week – on Tuesday, March 18 and again on Wednesday, March 19 – at the Bernice Pauahi Bishop Museum, Pākī II Conference Room, 1525 Bernice Street, Honolulu.

Beginning at 9 a.m. on Tuesday, March 18, the Commission will participate in a Strategic Planning Workshop for the purpose of evaluating and developing a Strategic Business Performance and Organizational Plan to manage the Kaho'olawe Island Reserve (KIR). The workshop will extend into the morning session of the Wednesday, March 19 meeting, beginning at 8 a.m.\*

Following the Wednesday morning workshop session, the regular monthly meeting of the Commission will convene at 12 noon. Among agenda items, are:

- A. Approval of the posting of a Request for Proposals to manage Honokanai'a Base Camp;
- B. Approval of the implementation of the Sustainable Renovation (Volunteer Hut) Project proposed by Mr. Corey Boss, UH-Mānoa, School of Architecture; and,
- C. Approval of the publishing of the Draft Environmental Assessment for the 'Ōhūa in the Environmental Notice with KIRC Anticipation of a Finding of No Significant Impact.\*\*

KIRC Commissioners include Chairperson Noa Emmett Aluli, M.D., Vice-chair Robert J. Lu'uwai, and members Milton M. Arakawa, A.I.C.P., Charles PMK Burrows, Ed.D., Craig Neff, Laura H. Thielen and John D. Waihe'e IV. Michael K. Nāho'opi'i is Executive Director.
