Commissioners will discuss the following Legislative Bills; HB1223, SB815, HB1224, SB816, HB711, SB817, SB609, and SB1402 and develop and approve testimony. The KIRC establishes policies and usage of the island and its surrounding waters through comprehensive restoration and monitoring programs. The KIRC Cultural Program integrates a Native Hawaiian cultural perspective into all programs and activities. The organization is managed by a seven-member Commission and a committed staff.
